- b) To establish and /or contribute to, support, or maintain by monetary gifts or otherwise, educational or cultural institutions, colleges, schools, libraries, book-trusts, reading rooms, industrial training institutes, technical institutes, polytechnics, workshops, cottage and small scale industries, research institutes and other public educational or cultural or charitable institutions or societies.
- c) To hold and promote education and learning including primary, higher and college education, technical, non-technical, agricultural, engineering, medical, commercial, financial, management, scientific philosophic or any subject relating to arts, culture or any other subject of education and research work in all subjects, and to establish, run, maintain or finance by Adhoc or annual grants or otherwise schools, colleges and/or other institutions for all or any of the aforesaid purposes.
- d) To establish professorship, lectureships and to give scholarship and prizes or any other similar help or encouragement for the advancement of education.
- e) To make pecuniary grants by giving scholarships, education fees, fellowships, stipends or otherwise to deserving or meritorious or poor students for their studies, research and training, education, etc. in any branch including free or concessional supply of their food, clothing, residence, books, etc.

- a) The number of Trustees shall not be less than Ten and shall not exceed Nineteen.
 - b) The number of Trustees may be altered accordingly to the decision of the Board of Trustees, subject to clause (a) supra.
 - c) Vacancies caused by removal, death, retirement, resignation or by any other incapacity or reason in the board of Trustees shall be filled by co-option by remaining Trustees.
 - d) The managing Trustees shall manage the affairs of the Trust on behalf of the Board of Trustees and shall be the person to sue or be sued on behalf of the Trust.
- 5. POWERS OF TRUSTEES:** Without prejudice to the General Powers of the Trustees to manage the Trust, the Trustees shall have the following powers for the management and administration of the Trust and for the execution of the objects of the Trust.
- e) To keep the Trust properties or apply the Trust Funds for the acquisition of any kind of property or assets whatsoever including movable, immovable, actionable claims, securities, shares, stocks or any other form of property.

- b) To open one or more bank accounts in the name and for the Trust anywhere in India and the Secretary and the Treasurers shall be authorised to have the power to operate such bank accounts jointly
- c) To invest Funds of the Trust in any moveable or immovable property in any part of the country (India) and further will have the power to sell or vary such investments according to their discretion from time to time.
- d) The managing Trustee shall maintain or cause to be maintained proper books of accounts of the monies, properties, income and expenditure of the Trust which shall be audited every year by a Chartered Accountant duly appointed for the purpose.
- e) The Trustees shall have power to collect rent, interest or other income and invest the Trust Fund and vary such investments from time to time and sell or realise the investment for the purpose of the Trust. However, the Trustees shall have limited powers to mortgage, raise loans or encumber, sell or lease out for a period exceeding one year, or otherwise alienate the immovable properties, if any of the Trust unless and until necessity or occasion compels such a sale, transfer or encumbrance, or other alienation of the immovable properties. In any such event, the Managing Trustee shall be competent to sell, lease, encumber or otherwise alienate the properties of the Trust, after due authorisation by the Board of Trustees.

- f) To do all such acts and things as are necessary for the control and management of the affairs of the Trust and for purposes of attainment of the objects of the Trust.
- g) To raise such loan or loans for the benefit of the Trust and to sign such promissory notes, bills of exchange, hundies or any other financial documents that may be necessary for and on behalf of the Trust.

- n) To appoint such staff as may be necessary for the due administration of the Trust on such remuneration, commission or salary as the Trustees may think proper and suspend, remove or replace them whenever necessary.
- o) To reimburse the Trustees towards the pocket expenses which may be incurred by them in the course of or in relation to the affairs of the Trust.

- 6. **POWER TO CO-OPT:** The Trustees shall have the power to co-opt additional Trustees or to fill up any existing vacancy in the Board of Trustees, so however, that the total number of Trustees shall not be below or exceed the number fixed in clause 4(b) supra.

7. **VACANCIES OCCURRING IN THE OFFICE OF THE TRUSTEES:** The vacancies occurring in the office of the Trustees shall be filled by the remaining Trustees within 3 months of the arising of such vacancies. If there are no Trustees, functioning at any point of time, the Trustees shall be appointed in accordance with the law by a court of competent jurisdiction. Where at any time the number of Trustees fall below the minimum prescribed in clause 4(b) supra, the continuing Trustees shall give the power to co-opt any person or persons to fill up such vacancy.
8. **VACANCY NOT TO INVALIDATE THE PROCEEDINGS:** Any vacancy in the Board of Trustees and /or any illegality in appointment of Trustees, their proceedings shall not invalidate any prior act or decision of the Board of Trustees.
9. **ADMINISTRATION:** The Board of Trustees shall have full power and authority to administer the Trust, its properties and affairs and do all acts, deeds and things which are calculated to fulfil the performance for which the Trust is established. The Board of Trustees shall act through the Managing Trustee.
10. **APPOINTMENT OF MANAGING TRUSTEE:** The First Chairman shall be Shri T. Kuppusemi who shall hold office for a period of one year. Thereafter a Managing Trustee shall be selected from amongst the Board of Trustees to hold office for a period not exceeding one year. The Managing Trustee shall have all the powers vested in the Board of Trustees and shall act on behalf of the Board of Trustees subject to the overall control and superintendence of the Board of Trustees.

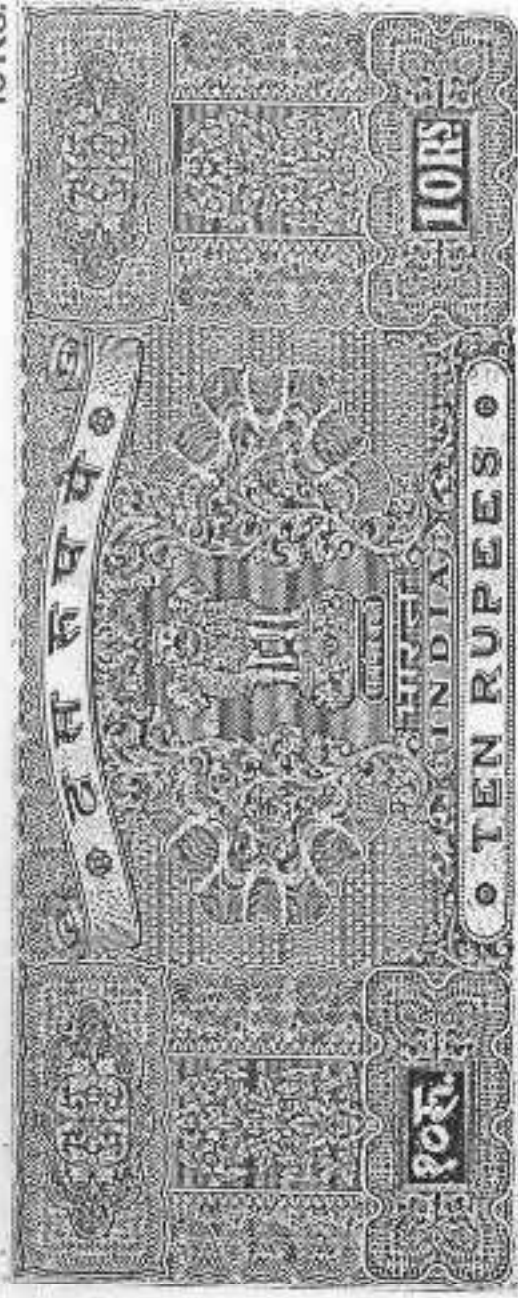

11. **PROCEEDINGS OF THE TRUSTEES:** The Board of Trustees may meet as often as may be necessary for the efficient conduct of the Trust. The Trustees may take decisions on any matter either at their meetings or by circulation of resolution on papers. If any of the Trustees are absent for 3 consecutive Board Meetings without a prior leave of absence sanctioned by the board, he shall be deemed to have vacated his office
12. **QUORUM:** The minimum number of Trustees to be present for conducting a meeting of the Board of Trustees shall be 5 or 1/4th of the Total number of Trustees whichever is less.
13. **VOTING:** Each Trustee shall have one vote. The opinion of the majority of the Board of Trustees present at a meeting shall be final in respect of all matters relating to the Trust.
14. **MINUTES, ACCOUNTS AND AUDIT:** The Trustees shall maintain true and correct accounts of the Trust and a correct record of their deliberations and get the accounts duly audited by a Chartered Accountant.

15. NET INCOME OF THE TRUST: The Trustees shall invest and cover the income of the Trust Fund and shall provide for all costs, charges, incidental expenses, including insurance premium expenses of ordinary repairs etc. and all other out goings and expenses for the management and administration of the Trust.

16. CREATION OF RESERVES: The Trustees shall set apart and credit to the depreciation sinking or other Fund, such percentage of, or portion or whole of the income of the Trust Fund as may from time to time be determined by the Trustees. However, as and when the balances standing to the credit of such Fund exceeds the minimum amount, which the Trustees may from time to time consider sufficient. It shall be lawful for the Trustees to transfer such surplus amount to the General Trust Fund and apply it in the same manner as the Net income of the Trust Fund.

17. APPLICATION OF INCOME AND TRUST FUND: The Trustees shall, after providing for the aforesaid payments and disbursements and after setting apart any sum for sinking Fund, reserves etc apply and utilise the net income or the corpus of the Trust, or the Trust Fund for the fulfilment of all or any of the Public Charitable purposes or objects of General Public utility referred to in Para 2 supra by such ways and means as the Trustees may from time to time in their absolute and unfettered discretion determine

- 18. TRUSTEES AND THEIR RELATIVES NOT TO BENEFIT:
Notwithstanding the power vested with the Trustees under the proceedings clauses, no part of the income of the Trust shall ensure directly or indirectly, and no part of the income or property of the Trust shall be used or applied directly or indirectly, for the benefit of the Trustees or any person who makes a substantial contribution to the Trust or any relative of the Trustees or the person who makes a substantial contribution.
- 19. NO REMUNERATION TO THE TRUSTEES: The Trustees shall not be entitled to draw any remuneration from the Trust.
- 20. LIABILITY OF TRUSTEE OR TRUSTEES: In the professed execution of the Trust and powers conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent or employed by him (or by any other Trustee thereof) although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the Trustees or by reason of any other matter or things except willful or deliberate fraud on the part of the Trustees, who alone may be subject to be made so liable.

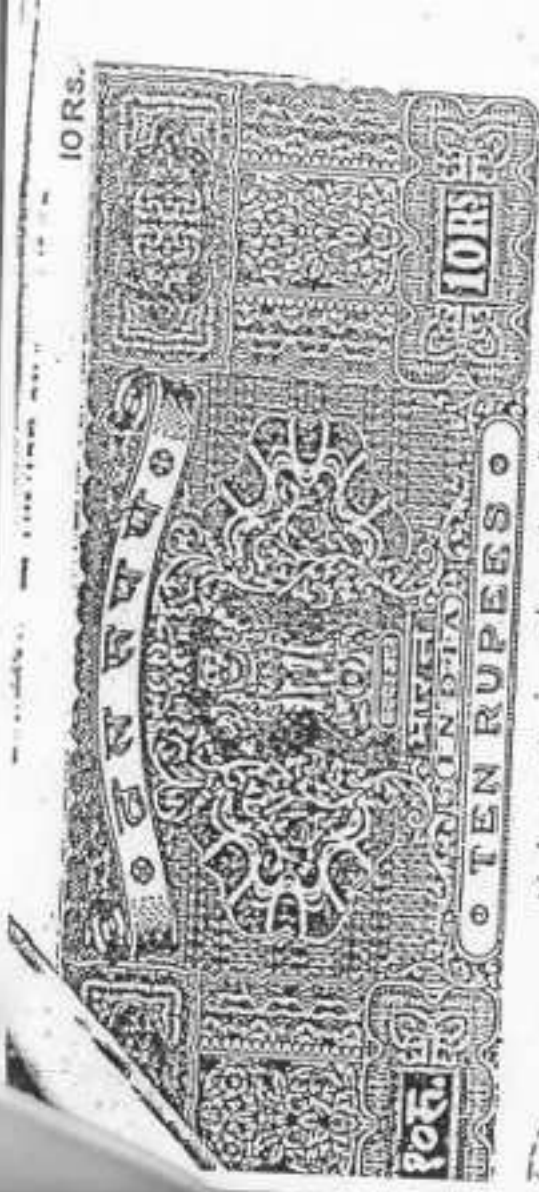

22. **IRREVOCABILITY:** the Trust is Irrevocable.

23. **INCOME-TAX MATTERS:**

- e) Any amendment to the Instrument creating the Trust shall be carried out only with the approval of the Income-tax Authorities, more specifically, the Director of Income-tax (exemptions)
- b) The activities of the Trust shall be confined to the Territories of India.
- c) The Funds of the Trust shall be utilised only towards the objects laid out in the Deed of Trust, and no portion of it shall be distributed in any manner to the Trustees or to persons in Section 13(1)(c) of the Income-tax Act, 1961.
- d) The benefits of the objects of the Trust shall be made available to the general public irrespective of caste, creed, religion or sex.
- e) The Trust shall not carry out any of the objects with the motive of profits of any kind.

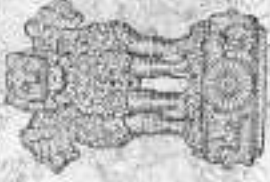


